***Inherently Hazardous and Potentially Dangerous Event Release of Liability and Assumption of Risk Agreement***

1. **NOTICE:** Your execution of this release agreement will prevent you, your heirs, administrators, assigns and legal representatives from recovering or bringing a claim against the SSMR, Shuswap School of Motorcycle Riding, or any of its employees, or anyone in any way connected with your participation in the Shuswap School of Motorcycle Riding's Training Program ("The Event").

3. **ACKNOWLEDGEMENT AND ACCEPTANCE OF RISK:** I understand, acknowledge, and am aware that the Event is an inherently hazardous and potentially dangerous activity in which, as a participant, I may suffer serious bodily, psychological, physical and neurological injury or death, or cause injury to another's person or property. # Gear List

**Leather Boots** - Covering the ankles completely, low heel

**Leather Gloves** – Full fingers, no exposed skin

**Leather Jacket** – Heavy denim will do, but leather will offer far more protection.

**Leather Chaps/Pants** - Heavy denim will do, but leather will offer far more protection.

**Bring all of your gear every day of training!**  
(You will not be permitted to ride without all of the required riding gear)

**Students must have their valid class 6/8 drivers license on their person at all times during the course.** (You will not be permitted to ride if you fail to bring your license)

# Course Costs & Descriptions (Prices do not include GST)

**New rider's course: \$679(Class 6/8L) Designed for people with little or no experience on a motorcycle**

\* **Also available in ladies only** This is an in-depth course totalling 27 hours, 10 hours theory, 11 hours motorcycle skills and 6 hours in traffic, (we supply the motorcycle and helmet). We will get you started and build your riding skills on the range. After successful completion of the MSA test, our instructor will teach you to ride safely and defensively in a traffic environment. Students must hold a valid class 6/8 motorcycle learners license.

**Accelerated Course \$550** If what you want is to get past the dreaded skills test (MSA Test) then this is the course for you 8 hours theory, 10 hours motorcycle skills plus MSA test (no in traffic training)

**MSA Re test \$50** Comes with 1 hour of instruction

**Extra training: \$40. per hour.** If you are already enrolled in our course

**Individual lessons: \$65. per hour.** Use of our bike and helmet included. (\$55. per hour, your bike & helmet)

**Road test escort \$75** Students will receive an hour of in-traffic instruction, pointers and tips, ensuring that you arrive at your I.C.B.C. road test on time, confident and ready. We will wait for you to complete your test, then escort you back, (use of our bike and helmet included)

**Evaluation and training: \$125** For riders who have not taken our (new riders course) and are ready to take their I.C.B.C. road test. An instructor will assess the rider's skills and offer feedback, as well as valuable tips. Includes 2 hours of in-traffic training.

## Shuswap School of Motorcycle Riding Policies & Information

- Applications will be processed in the order in which they are received with payment.
- Full payment must accompany all registrations. For your convenience, we accept cash and cheques.
- A fee of \$20.00 will be assessed for NSF cheques.
- Courses run rain or shine.
- SSMR reserves the right to ask a student to leave the course if that student is intoxicated or behaving in a manner that puts the student or those around him/her in a dangerous situation. Refunds will not be considered.
- Students must bring proper gear (see Gear List), a valid BC Driver's License, and a valid Motorcycle Learner's Permit (if applicable) to each day of class. Without these, students will not be permitted to participate. Refunds will not be considered.
- Novice students must obtain their Motorcycle Learner's Permit prior to the first day of the course. Contact ICSC to obtain the appropriate study guide. We recommend that students take their Class 6/8 Motorcycle Learner's Permit test well in advance of their course start date. Some students find this test challenging, and may need to take it more than once. Failure to obtain a Learner's permit before the start of a course will prevent a student from participating in the course. Refunds will not be considered.
- Due to the progressive nature of the course, a student may be prevented from completing the course if he/she misses a day of instruction. Although we will do whatever we can to provide make-up lessons on a cost-recovery basis, refunds will not be considered.
- Students may be recommended for Extra Training (see above fees) if their skills are not adequate to progress to the next day.
- Completion of the course does not ensure success with the ICBC Road Test
- Due to the condensed time frame of the course it is recommended for those who are physically fit or who have had some previous motorbike or motorcycle experience.
- In an effort to provide a healthy learning environment for our students, smoking is not permitted on grounds or during course time.
- Students registering must attend all four listed dates, but then have a choice whether to take the Traffic Skills course or not
- Agreement between Insurance Corporation of British Columbia and Motorcycle Skills Assessment Facility requires that each facility shall provide written notice to each student that:

**5.13.1** - Certification by the Facility does not guarantee that ICBC will issue an Unrestricted Class 6or 8 Learners License

**5.13.2** - If a trainee does not successfully complete MSA (Motorcycle Skills Assessment), ICBC will not waive the minimum waiting period before the trainee can take a Motorcycle Skills Test. Whether or not the trainee has completed the Motorcycle Skills Training program

**5-13.3** - ICBC may require a certified trainee to be retested by a Driver Examiner

**5.13.4** – ICBC will have access to the trainees Motorcycle Skills Training and MSA records

### Cancellations & Transfers

- Cancellations made 14 calendar days or less prior to the start date of a course will not be refunded.
- Cancellations made 15 calendar days or more prior to the start date of a course will be refunded less a \$75 cancellation fee
- Road Test Escort and Training sessions that are cancelled with less than 48 hours notice will be non-refundable
